## **Data protection notice:**

### **1. The name and contact details of the controller**

The city council of Halle (Saale) represented by the Lord Mayor - central contact via DLZ Bürgerengagement am Marktplatz 1 (Civic engagement service centre), 06100 Halle or by calling +49(0)345 22 10 - only processes your personal data in the health department at the request of the health authorities.

### **2. Principles and legal basis of the processing**

Personal data are collected on the basis of the Eleventh Regulation on Measures to Contain the Spread of the Novel Coronavirus SARS-CoV-2 in the federal German state of Saxony-Anhalt (Eleventh SARS-CoV-2 Containment Regulation - 11. SARS-CoV-2-EindV) Section 1 paragraph 1 and 5 for the purpose of investigations into acute infections in individual cases in connection with SARS-CoV-2 and processed in conjunction with Section 28 of the German Infection Protection Act (IfSG)

On the basis of the Eleventh Regulation on Measures to Contain the Spread of the Novel Coronavirus SARS-CoV-2 in the federal German state of Saxony-Anhalt (Eleventh SARS-CoV-2 Containment Regulation - 11. SARS-CoV-2-EindV) Section 1 paragraph 5 the following information shall be recorded: Forename and surname, complete address and telephone number, period and place of your stay.

### **3. Recipients or categories of recipients**

Your data may only be provided to the Health Department in order to fulfil this task.

We do not transmit the data to third countries.

Otherwise, your data will only be passed on if there is a legal obligation to do so or if you have consented to this.

### **4. Duration of storage**

According to Section 1 paragraph 5 of the Eleventh Regulation on Measures to Contain the Spread of the Novel Coronavirus SARS-CoV-2 in the federal German state of Saxony-Anhalt (Eleventh SARS-CoV-2 Containment Regulation - 11. SARS-CoV-2-EindV), the data must be irreversibly deleted by the city council four weeks after their collection. The Health Department may request the collected data if this is necessary in order to trace contacts. The Health Department will not further transfer the data or use them for any other purposes. The data transferred to the Health Department must be permanently deleted once the data are no longer needed for tracing contacts.

### **5. Rights of the data subjects**

You have the right to access your personal data stored by us (Article 15 GDPR) as well as the right to correct them (Article 16 GDPR) or delete or restrict their processing (Articles 17, 18 GDPR). Furthermore, you have a right to object (Article 21 GDPR) to the processing, insofar as this is not performed exclusively for the fulfilment of tasks, and a right to transferability (Article 20 GDPR) of the data provided by you.

If you should make use of your aforementioned rights, the Halle (Saale) city council will check whether the legal requirements to this end have been fulfilled.
